IV.

Membership fee

1. Members of the association pay a membership fee as a contribution in kind. The membership fee is a minimum of 3,000 HUF per year, that is minimum three thousand forints per year, to be paid in lump sum within 8 days from the date on which the order for registration becomes final, and then by 1 May at the latest of each year to the association's treasury or to the association, by bank transfer to the bank account.

After the formation of the Association, the newly joining member shall pay the amount of the membership fee proportionally calculated within 8 days from the establishment of the membership relationship, and by 1 May of each year thereafter, by transferring it to the Association's treasury or to the Association's bank account.

V.

Membership

The alliance is a type of association, that can be established and operated with the participation of two 1. members. A member of an alliance may be an association, foundation, other legal entity, an unincorporated organization or a non-governmental organization; a natural person may not be a member of an association. Members of the Alliance may be any legal entity without legal personality which agrees with the purpose of the Association and intends to actively participate in its activities in order to achieve its objectives and accepts the provisions of the Statutes.

VI.

Establishment of membership

1. The membership of the alliance is established upon registration of the association. After the formation of the association, membership shall be granted upon acceptance of the declaration of entry. The application for admission must be submitted to the Presidency, which shall decide on admission by a simple majority, by open majority, within 30 days of receipt of the application. Its decision shall be communicated to the applicant in writing within eight days of the date on which it is taken in writing. There is no right of appeal in the event of a refusal of the application for membership.

VII.

Termination of membership

- 1. Membership ceases:
 - a. / Withdrawal of a member.
 - b. / With the termination of the member without legal successor.
 - c. / Excluding a member.
- Members may terminate their membership at any time by giving written notice to the Presidency of the
 Association without giving any reason. Membership shall cease on the date on which the Member's
 declaration is received by the Presidency.
- 3. The Presidency may exclude any member from the members of the Association by open vote, who has grossly or repeatedly behaved in a manner contrary to the provisions of these Statutes or to the decision of the General Assembly.

A member can be excluded even if he / she has not paid the membership fee for six months. Failure to pay the membership fee shall result in the member being excluded only if, after a period of at least six months, the Presidency has requested in writing, with a grace period and warning of legal consequences ie exclusion, and the call remained unsuccessful even after the extra deadline.

The exclusion procedure is lead by the Presidency at the initiative of any member or federal body. In the exclusion procedure, the member shall be invited to attend a meeting of the Presidency metting, with the warning that his or her absence, despite being duly invited, shall not prevent the meeting from being held and the decision being taken. He must be given the opportunity to defend himself at the meeting. A member may be represented at the meeting by, or in place of, the legal representative. Any decision to exclude a member shall be made in writing and shall state the reasons on which it is based; the justification shall include the facts and evidence on which the exclusion is based and information on the possibility of redress. The General Assembly

- 2. The General Assembly is the decision-making body of the Association.
- 3. The General Assembly shall be responsible for:
 - (a) amendments to the Statutes;
 - (b) deciding on the dissolution, merger or division of the alliance;
 - c) election and removal of the chief executive officer and the member of the supervisory board;
 - (d) adopting the annual budget and fixing the membership fee;
 - (e) adopting the annual accounts, including the report on the financial situation of the Association, issued by the Governing Body;
 - (f) adoption of a public benefit annex;
 - (g) exercising employer's rights over the chief executive officer if the chief executive officer is employed by the association;
 - (h) approving the conclusion of a contract between the Association, its member, its chief executive officer or a relative;
 - (i) deciding on claims for compensation against current and former federal members and senior officials;
 - (j) deciding on any matter to which the statute or statutes refer.
- 4. The Assembly shall meet at least once a year.

If the general meeting has not been convened in a proper manner, the meeting may be convened if at least three quarters of the persons entitled to attend the meeting are present and unanimously consent to the meeting being held.

The invitation to the general meeting shall include the name of the association, its seat, the place, time and the proposed agenda of the general meeting. The items on the agenda shall be set out in the invitation at least in such detail as to enable voting members to express their views. The invitation shall also include the date and place of the repeat meeting in the event of the quorum of the general meeting and a call for the General Assembly to have a quorum for any item on the original agenda, irrespective of the number of those present if the original date is called at least half an hour and up to fifteen days later.

The notice of the general meeting shall be made public at the headquarters and website of the Association.

Members and bodies of the Association may request the Presidency to supplement the agenda within 3 days of delivery or publication of the notice of the general meeting, with a justification for the addition. The Presidency shall decide within two days on any additions to the agenda. The Presidency may refuse to supplement the agenda or grant the request. It shall communicate its decision, and, if adopted, the supplemented agenda items in all cases from the time of their adoption to the members within 2 days of its adoption, in a verifiable manner.

If the Presidency does not decide on a request to add to the agenda, or rejects the request, the General Assembly shall decide separately on the addition to the agenda before the decision on the agenda is adopted, except that a decision on an item which has not been duly announced at least three-quarters of those entitled to attend are present and contribute unanimously to the deliberations.

- 6. The Presidnet shall convene the general meeting without delay to take the appropriate steps, if:
 - a. / the assets of the association do not cover the debts due;
 - b. / the association is not expected to be able to pay its debts when due; or
 - c. / the achievement of the association's goals is at stake.

Members present at the general meeting shall be recorded in a attendance list, which shall include the name -where the statutes allow for representation,- the name of the representative and place of residence or seat of them. If the members do not have the same number of votes, it should include the number of votes of the member it is entitled to. The attendance list shall be authenticated by the signature of the President of the general meeting and the Registrar.

Minutes shall be taken of the general meeting which include

- 13. The Presidency shall be the governing body of the Association, which shall consist of 5 members and shall decide on all matters not covered by the exclusive competence of another body in law or the statutes of association.
- 14. The members of the Presidency shall be elected by the Assembly for a fixed term of 5 years. A senior executive position is created by accepting the position by a designated, elected or appointed person.

The term of office of the Chief Executive Officer shall be terminated:

- a. / at the end of the term of the order;
- b. / by removal,
- c. / by resignation;
- d. / upon the death or termination of the Chief Executive Officer without a legal successor;
- e. / in the event of limited ability of the chief executive officer to carry out his / her activities;
- f. / in the event of a disqualification or a conflict of interest with the Chief Executive Officer.

The General Assembly may recall the Chief Executive Officer at any time without giving reasons. The General Assembly shall decide on the recall.

The Chief Executive Officer may resign at any time by submitting a statement to the Association and addressing it to another member of the Association. If required by the legal capacity of the legal person, the resignation shall take effect upon the appointment or election of a new chief executive officer or, in the absence thereof, not later than sixty days from the date of notification.

15. A senior official may be a person whose legal capacity has not been restricted to the extent necessary to carry out his activity. If the chief executive officer is a legal person, the legal entity shall designate the natural person who will perform the executive functions on his / her behalf.

The rules applicable to senior officials shall also apply to the designated person. The executive officer is personally responsible for the management duties. It cannot be a senior official who has been finally sentenced to imprisonment for committing an offense until he/she has been released from the adverse consequences of the criminal record. It cannot be a senior official subject to a judgment prohibiting public affairs (Section 61 (2) (i) of the Criminal Code). It cannot be a senior official who has been definitively banned from this profession. A person who has been barred from practice by a judgment which has the force of res judicata may not, during the period covered by such prohibition, it cannot be a senior official of a legal person engaged in the activities specified therein. For the duration of the prohibition decision, a senior official shall not be prohibited from being a senior official.

- 24. The Supervisory Board shall have the power to:
 - control of the management to protect the interests of the association;
 - controlling the operation and management of the association.

The Supervisory Board may request reports from senior executives and information from employees of the association in the performance of its duties, and may review and inspect the books and records of the association.

- 25. The Supervisory Board shall investigate the proposals submitted to the decision-making body of its members and shall present its position thereon at a meeting of the decision-making body. The Supervisory Board may consult the association's records, accounting records, books, request information from senior executives and employees of the legal entity, inspect the legal entity's payment account, cash register, securities and merchandise, and review its contracts.
- 26. The Supervisory Board shall hold meetings as necessary and at least once a year. The Chairman of the Supervisory Board shall convene the Supervisory Board meeting in writing, at least 15 days before the

date of the meeting, primarily at the seat of the Association, in a verifiable manner. The following shall be deemed to be service in writing: delivery by registered or acknowledgment of receipt, and delivery to the member's electronic mail address with acknowledgment of receipt (electronic acknowledgment of receipt).

The invitation to the Supervisory Board meeting shall include the name of the association, its seat, the place, time and proposed agenda items of the Supervisory Board meeting. The items on the agenda shall be set out in the invitation at least in such detail as to enable the members of the Supervisory Board to formulate their views.

27. Unless otherwise provided in the statutes of association or law, the Supervisory Board shall take its decision by a simple majority of votes and by open vote. The Supervisory Board shall have a quorum if more than half of the members of the Supervisory Board not restricted by their voting rights are present at the meeting. In the case of two members of the Board of Supervisors are present, only unanimous decisions may be taken.

The person shall not vote when making the decision,

- (a) who is relieved of the obligation or liability of the decision or otherwise favors the legal person;
- (b) with whom the decision is to be concluded;
- (c) against whom the decision is to be sued;
- (d) whose relatives are interested in the decision and who are not members of the Association;
- (e) has a majority interest in the decision-making organization; or
- f) who is otherwise personally interested in the decision.
- 28. The Supervisory Board shall announce the decisions of the Supervisory Board orally at the meeting of the Supervisory Board and communicate it in writing to the member(s) concerned within eight days of the resolution being made, simultaneously with the publication of the resolutions on the website of the Association.

Final provisions

Issues not regulated by the Statutes of Association are governed by Act V of 2013 on the Civil Code and by Act CLXXV of 2011 on the right of association, the legal status of public benefit and the operation and support of civil organizations. (Ectv.).
